Até a data/hora limite para recebimento das propostas, apresentaram suas propostas as empresas relacionadas no resumo de cotações abaixo, classificadas pelo menor valor.

No dia 12/06/2023 às 14:08 horas, as propostas foram enviadas para análise técnica.

Após o parecer técnico emitido pelo coordenador do projeto, a comissão resolve:

Desclassificar a proposta apresentada pela empresa Walder C Teixeira para o item 1 pelo seguinte motivo: o número de pentes de memória solicitado pelo edital deve ser 4 ou 8, diferente do único pente apresentado na proposta (item 5.1). Adicionalmente, os HDs são apresentados em 3 discos SATA, sendo que o edital solicita que os 24TB de disco SATA sejam distribuídos em pelo menos 4 discos (item 6.1).

Desclassificar a proposta apresentada pela empresa Lider Notebooks para o item 1 pelo seguinte motivo: O processador apresentado não atende ao solicitado no edital (item 4.1) onde é solicitado que os processadores sejam de 2.1 GHz diferente do 2.0GHz apresentado na proposta. Adicionalmente, o número de ventiladores do equipamento não é equivalente ao solicitado no edital, sendo apresentado um equipamento com 4x diferente dos 6x requisitados no edital (item 8.1).

Após o julgamento das propostas pelo menor preço pela equipe técnica, conforme disposto no edital, a comissão de seleção decidiu como classificadas nesta etapa do certame observada as condições expostas acima, a empresa:

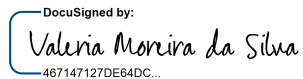
