# ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

# **Getting paper copies**

You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. ### Withdrawing your consent

# All notices and disclosures will be sent to you electronically
