## ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, Fundação Arthur Bernardes (we, us or Company) may be required by law to provide to you certain written notices or disclosures. ## **Getting paper copies**

## Withdrawing your consent

If you do not agree with this process, please let us know as described below.
