

## **ELECTRONIC RECORD AND SIGNATURE DISCLOSURE**

From time to time, Fundação Arthur Bernardes (we, us or Company) may be required by law to provide to you certain written notices or disclosures. ### **Getting paper copies**

### **Withdrawing your consent**
